- a. Executive & Associate Directors Please see attached director's report.
 - i. Conrad reported on progress of effort towards change in tax law. The proposed change might have to be changed to be Hutchinson specific for it to pass this year.
 - ii. NDMA will host a Business After-Hours, a chamber of commerce event, on April 13th from 4-6 p.m. NDMA will have a booth at the Hutchinson "Bring it Home Expo" at the Hutchinson Fairgrounds on April 8th.

- iii. This month's meeting with representatives from the boards and administration of NDMA and NCA focused on transportation, FY18 calendar and determining interest in merger of the schools (families with students enrolled in the schools will be asked to respond to a simple survey in April).
- iv. Kinzler shared an example of a Weekly Staff Bulleting that she distributes to staff included are week at a glance items and upcoming events, along with additional updates and announcements. MS (Rahkola/Selchert) to approve review and update of policies 706.1P Gift Acceptance, 706.2P Real Estate Gift, 709P Student Transportation, 790P Reporting Grants to Board, 798P Joint Venture, 799P Record Retention haven't had to use provisions of 706 policies yet, but maybe someday NDMA will receive substantial gifts. NDMA will continue to use a shortened version of the MSBA student transportation policy template as we contract out transportation services and expect the transportation company to comply with all legal driver and vehicle requirements. Motion carries.
- b. Discuss FY18 School Calendar construction project at Hutchinson High School is enough ahead of schedule that ISD 423 plans to begin school right after Labor Day. The district does not plan to submit a proposed calendar until their April board meeting, and NDMA administration would like to see that document prior to submitting an NDMA FY18 calendar for approval as they want to present a calendar with as many compatible days off as reasonable with surrounding districts' calendars.
- c. MS (Enerson/Selchert) to approve FY18 Salary Structure and Staff Benefit Package there will be no changes to the salary structure and benefit package that was introduced and approved for FY17. Roll call vote unanimous; motion carries.
- d. Accept Nominating Committee Recommendations the committee recommends Jennie Pirnie be placed on the ballot as a community member and an additional potential community member candidate. There are also two potential teacher candidates (they originally asked if the could share a position on the board, but will be told that is not allowable).
- e. Students moving on from NDMA. Pirnie reported on an encounter she had with a former NDMA school who is currently attending Hutchinson Middle School. This led to a discussion and sharing of the experiences of other students moving on to middle school and high school. Most experiences shared were positive even though the student Pirnie referenced prefers 6th grade at the middle school to the E2 classroom at NDMA. Consensus was experiences at NDMA prepared students well for middle school and beyond.
