Executive Director Report for NDMA's Board of Directors – Dave Conrad Monday, May 16, 2016

1. Application for Grade Level & Site Expansion

- ACNW has declined consideration of the application until we provide further information. We can/will present an amended application for their consideration in July.

2. Montessori Credentials

 I am happy to offer congratulations to Peggy Enerson for completing her Masters in Montessori Education at the University of Wisconsin, River Falls. Thank you, Peggy, for persevering.

3. Recycled Materials for Playground Structures

- A volunteer work group is planning to begin the work of adding some play structures to our playground on Saturday, May 21st from 9 to 11 a.m. The will be doing prep work like removing nails, etc. from recycled lumber, and finishing the interior of the parade school house with recycled materials. In addition, if time allows, platform construction may commence for a new play structure.
- On June 11th we will have another volunteer work group assemble to move fencing to increase our playground footprint to include some grassy area near the building.

8. Sections for 2016-17

- The administrative team is discussing options for grade configuration for the coming school year due to the bubble classes working their way through.
 - If enrollment supports it we would love to open a second section of Children's House.
 - Due to the high number of students in next year's fourth, fifth and sixth grade sections, and the lower number of students in next year's first, second and third grade, we will have to select one of the following options (for example):
 - Two sections of Elementary I and three sections of Elementary II
 - Two sections of Elementary I, one hybrid section (2, 3 & 4) and two sections of Elementary II
 - Two sections of Elementary I, two hybrid sections (4 & 5) and one sections of sixth grade
