I would also like to give a shout-out to our families for being patient and gracious as we navigate this process. Thank you for working with us. Thank you for your encouragement.



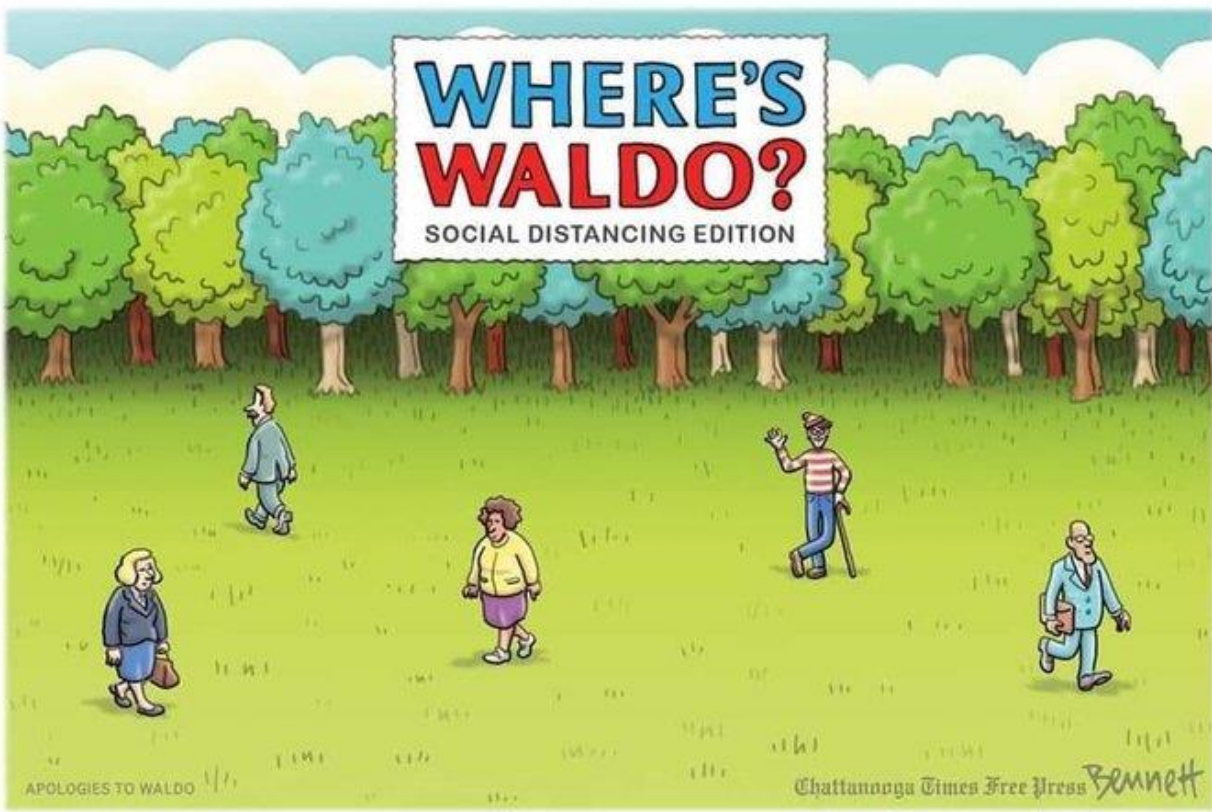

Just like the surf and the tide washing away the sandcastle, much of our hard work for the day is overcome by the updates, new mandates and/or clarifications we receive. The good news, though, is that we are not discouraged. We are grateful for the privilege to keep going, and to refine our work. The castle looks a little better every day.

United States Secretary DeVos announced this afternoon that students impacted by school closures due to the pandemic can bypass standardized testing for the 2019-20 school year. States need to apply for a testing waiver for this to happen. In response, the state of Minnesota announced today they *will* formally submit a request for a waiver so we will not have to participate in federally mandated testing requirements for the remainder of this school year.
